Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <input type="checkbox"/> <i>Toyota of Hollywood does not share with nonaffiliates so they can market to you.</i> 	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <input type="checkbox"/> Our joint marketing partners include finance companies.
