Who is providing this notice?	Dealership, as noted above.
What we do	
How does Dealership protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Dealership collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> ▪ complete an application with us ▪ open an account ▪ apply for a loan <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ sharing for affiliates' everyday business purposes – information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing with nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account – unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include those dealerships within the Performance Automotive Network.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>Our joint marketing partners include automobile manufacturers, providers and administrators of aftermarket products, financial companies, and companies that provide marketing services.</p> <p>As required by Chrysler Group, LLC (“Chrysler Group”), personal information generated by Dealer website forms will be used and tracked by Chrysler Group. Your personal information will be shared with Chrysler Group and may be used by Chrysler Group for their own marketing purposes. Dealership and Chrysler Group are nonaffiliated third parties and this website’s privacy statement does not apply to Chrysler Group’s website.</p>
